A RESOLUTION AUTHORIZING WEDC TO ENTER INTO AN AGREEMENT WITH OAKBEND MEDICAL CENTER FOR THE ERECTION OF EXTERNAL AND INTERNAL SIGNS AND LANDSCAPING AT THE FORMER GULF COAST MEDICAL CENTER TO FACILITATE INFRASTRUCTURE FOR AN EMERGENCY MEDICAL FACLITIY IN WHARTON

Wharton Economic Development Corporation ("Corporation") is a non-profit corporation organized under the provisions of Article 5190.6, Section 4B, Vernon's Texas Civil Statutes as amended, and,

WHEREAS the Corporation amended its fiscal year 2017-2018 budget to authorize the payment of \$250,000 to OakBend Medical Center ("OAKBEND") to install infrastructure including: exterior and interior signs and landscaping at the former Gulf Coast Medical Center established in Wharton, ("PROJECT") as a new business, and,

WHEREAS the funds will be distributed only upon completion of the PROJECT, and,

WHEREAS the standard performance agreement will be executed by Corporation and OAKBEND prior to any funding from Corporation to Oak Bend, and

WHEREAS the Corporation deems Oak Bend as necessary to future and current job creation.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF DIRECTORS OF CORPORATION that;

The Corporation amended its 2017-2018 Fiscal Year Budgets to make funds of \$250,000.00 available to OAKBEND to reimburse the costs of the PROJECT.

This resolution was adopted at a regular meeting of the Board of Directors of Corporation on December 18, 2017.
